Composition:

Each lozenge of 2.5g contains:

1- Pudina (Mentha viridis)	: 5.75 mg
2- Yashtimadhu (Glycyrrhiza glabra)	: 2.2 mg
3- Taila parni (Eucalyptus globulus labill)	: 1.5 mg
4-Mishtanimbuphala (Citrus sinensis)	: 0.5 mg
4- Karpura (Cinnamomum camphora Nees & Eberm)	: 0.18 mg
Excipients (Sugar, Purified water, Liquid glucose,	: q.s.
Supra yellow tartrazine (coloring), Honey flavor, Lemon flavor)	

Nutritional properties:

Neotravisil[®] Lemon and Honey helps relieve:

- All types of allergic cough, of infectious or asthmatic origin
- Cough associated with gastroesophageal reflux
- Cough caused by industrial dust / occupations

This product is a **food supplement, it is not a drug.**

Food supplements cannot be used as a substitute for a varied diet.

Posology and method of administration:

Orally

Adults (18 years and over) - Take one lozenge every 3-4 hours, do not exceed 6 lozenges per day. The lozenge should be placed in the mouth and retained until dissolved. Do not eat or drink 5 min after taking the lozenge.

Children (6 - 12 years old) - Take one lozenge every 3-4 hours, do not exceed 3 lozenges per day. The lozenge should be placed in the mouth and retained until dissolved. Do not eat or drink 5 min after taking the lozenge.

Duration of use: 1 to 2 weeks

Contraindications and precautions:

Hypersensitivity to one of the components of the formula
Avoid long-term use.

This product contains Tartrazine E102 dye and may cause allergic reactions. Neotravisil[®] Lemon and Honey lozenges contain sugar, it is recommended to use it with caution in patients with diabetes mellitus. Administer with caution to hypertensive patients with kidney or liver disease. The use of Neotravisil[®] is not recommended in pediatric patients and in pregnant or lactating women.

Undesirable effects:

Undesirable effects are rare if Neotravisil[®] is taken at the recommended doses.

Drug Interactions:

Drugs which are metabolized by the CYP450 enzyme accelerate the metabolism of co-administered products

Storage:

Store in a cool, dry place away from light.

Store at a temperature below 30 ° C.
